Ordering

After placing an order, you will receive an e-mail message from us acknowledging that we have received your order. Please note that this does not mean that your order has been accepted. Your order constitutes an offer to us to buy a Product or Service. All orders are subject to acceptance by us. The contract between us (Contract) will only be formed when you receive the Products and/or Services (as applicable).

Please note that products / services will not be delivered until we have authorization from your payment card issuer. We will not be liable if there is a delay, and we will not accept your order if payment is not authorized.

After you have placed your order, you will receive an email to acknowledge your order. It will confirm which products you have ordered, but it may not constitute an acceptance of your order. You may be directed to a third-party site to complete your order.

We do not have to accept your order, and for example, we will not accept your order if we do not have the products in stock, your payment is not authorized, there is an error on our website regarding the price or other details of the products / service, you have cancelled your order. We reserve the right to refuse any order.

Your Status

By placing an order through our web site, you warrant that:

- You are legally capable of entering into binding contracts;
- You are at least 16 years old;
- That you are not resident in a county where making a payment to our site, in line with these terms and conditions would breach any laws in that county.

Pricing and payment

Prices throughout the website are quoted in Euro, and payment can only be accepted in Euro. Product and Service prices include VAT, where applicable. Packing and delivery costs, if any, will be added to the total price of your purchase.
